CARB Type Program goes national

July 7 President Obama signed into law the Formaldehyde Standards for Composite Wood Products Act. This is an important strategic accomplishment for the composite panel industry, and calls for a standard modeled on California's "CARB rule". The legislation was conceived and championed by Composite Panel Association and directs the US EPA to develop and implement the new standard by January 1, 2013.

CARB extended the sell-through period that applies to distributors, fabricators, and retailers of finished goods made with pre-Phase 1 composite wood product panels to December 31, 2011 from June 30/11. The extension addresses excess inventories within California of finished goods made with pre-Phase 1 composite wood product panels due to the economic recession.

Monthly Shipments of North American composite panel (PB, MDF, Hardboard) producers in June is unchanged from May and up 7% from 2009
